David Blink reported that a student contracted Covid-19 in his in-person class yet there was no contact tracing of employees or students following exposure.

C. Committee Reports

1. **Distance Learning**—Chair Maria Fernandez reported that the committee has met and formalized the workgroups. Jude requested broader representation on the OER workgroup, looking specifically at definitions for Zero Textbook Cost. She is looking for two non-DL committee members. Jayne Turk volunteered.

- 2. Curriculum—Chair Neil Carpentier Alting reported the Curriculum Committee is continuing to help faculty with course review revisions. They are solidifying processes, specifically around cross-listing of courses. The deadline for new or substantially revised courses to be approved for CSU/IGETC AY 22-23 is Dec 3rd. Removing a pre-req is a substantive revision. Neil is contacting those faculty who may be impacted. Jayne Turk noted the recently passed law that requires community colleges, CSUs, and UCs to align their GE patterns. Concerns: it may eliminate several GE courses that students currently take and will impact adjunct faculty.
- 3. **Flex**—Chair Patrice Thatcher Stephens reported that the committee didn't meet yet due to Veteran's day holiday. The Optional Flex day worked out as expected.
- 4. **Equivalency**—Jenny Heath reported that Equivalency has not met since the last Academic Senate meeting.
- SLO- Chair Neil Carpentier Alting reported that SLO committee is working on the SLO module in eLumen and will have more discussion to bring to the next Senate meeting.
- 6. **SJEDI**—The SJEDI corner continues to report out in weekly emails.
- 7. **OER**—OER Liaison Jude Baldwin reported that students can now search the schedule for ZTC classes; we are now in compliance.

D. Action / Discussion Items

- 1. <u>Participatory Governance Handbook and Flow Chart of Committees and Councils</u>. Senate Exec reviewed the Participatory Governance Handbook, the flow chart, and the template from Chabot College regarding purpose, membership, responsibilities. Exec discussed that all the documents are necessary to show our processes.
 - Maria Fernandez noted that the arrows didn't reflect what was actually
 happening with flow of information. For example, IPB. If the arrows reflect
 the nature of the relationship and there should be arrows going both ways.
 Mike Tischler asked if we verifying if this is accurate or are we trying to
 improve it. Ron Slabbinck confirmed that we are looking for discrepancies
 between what is written and what we actually do. Dave Clarke suggested we
 call it an org chart.
 - In the Participatory Governance Handbook, Jayne Turk noted that the cochairs should be included before any changes occurs (not "if changes occur" as written on page 3). Also, "Committee appointments are made in consultation with the President": this is a shared governance model so this statement should be removed and the handbook should not be approved if it remains in the document. Jayne also noted the statement on anti-discrimination. It is not relevant here as it is already codified in other APs.

- Dave Clarke suggested the "option of presenting the concern to the board" for addressing violations of the handbook should be agendized instead, and not just a public comment.
- 2. <u>COVID-19 BP/APs</u>. Ron Slabbinck reported that the ASCCC voted to mandate vaccines, 89% in support. He is aware that this does not reflect on the sentiment on all campuses, but there needs to be meaningful protocols in place.
 - Chris Vancil said the district is not enforcing its mask policy. Mike Tischler
 questioned if there was anything in the AP about mask wearing. Monica
 Harle reported there is discouragement among the newly hired Covid
 monitors as there is no way for them to enforce mask wearing on campus.
 - Alison Varty asked how the college is going to enforce the vaccine or testing requirement. Ron Slabbinck noted that Dr Char Perlas shared Butte College's AP in College Council as an example. Employees who refuse to test or show proof of vaccination will be put on paid leave for the first week, unpaid leave for the second week, and then termination process begins for subordination. There is no such language in our AP. He also noted that the Board is doing a first reading of the BPs at the meeting tomorrow.
 - Natalie Bradley reported pushback from Administrators because she has been outspoken on Covid safety concerns in her area. Jayne Turk would like the President/Superintendent and VPAA to be present to hear our concerns.
 - DL coordinator Maria Fernandez has concerns about the directive that students can take online classes as an option instead of getting vaccinated or tested. It should not be a reason to learn online. The language around "choosing" is the issue. It is a modality of instruction and refusal to comply with Covid requirements is not an academic accommodation.
 - Jayne Turk voiced concern that AP 5210, section C, is still unclear.
- Vote to Appoint Faculty to the following committees: ADJ, Sabbatical Leave, PTK.
 - Patrice Thatcher Stephens and Ron Slabbinck will serve on the Superintendent Recruitment committee.
 - Maria Fernandez and Abner Weed will serve on the ADJ hiring committee,
 - Jayne Turk will serve on the Sabbatical committee with Neil as VP of the Senate.
