It was recommended that we survey students. Fernandez is working with Regina to post a survey in Canvas. The survey will include questions which identify barriers in taking online courses and, Fernandez will now add a question asking 'why are you taking this course online?' It was also recommended that Online instructors survey their students. A question was brought up regarding success rates of online students and discussion ensued about the quality of online courses. To be eligible to teach Fall 2020, instructors must take the intro to online training by April 15th. Issues were also brought up regarding our VC rooms. If you notice an issue with the VC room, please submit a Happy Fox request.

II. Non-Resident Tuition & 320 first report – Gross

Gross detailed the 320 report which includes resident and nonresident students. The report looks at enrollment trends. Total FTES 2047.

We do not receive apportionment for Nonresident students instead we receive funding based on the Non Resident Tuition rates. Gross solicited feedback on the Non Resident Tuition rate. It was stated, that the lower the rate, the better. It was asked how we make up our costs since our current rate does not meet expenses. Gross mentioned that we have other funds that help support those efforts. Oregon 'Good Neighbor' program discounts tuition for Oregon students.

ACTION: The committee recommends a \$280 Non Resident tuition rate.

III. Library Update (I) – Baldwin

Then Library has migrated to a new platform. All videos and tutorials have been updated. Working with IT for the logins for the system. For SP20 the login is different than logging into email (people must use entire email address to login). The search box on the library home page will be improved. Data base content is slowly being integrated into the catalog. Will be seeking student feedback to help make improvements.

IV. In-Service Courses 9000 (I/A) – Witherell

In-service courses, mainly in the CTE area, can be confusing because they are sometimes graded and other times P/NP. Offered in EMT, ADJ and FIRE. None of the areas require a grade for the course. The COR would need to be revised to remove the letter grade option.

ACTION: Peretti moves. Klever 2nd. All Approved. COR to be revised and forwarded to Curriculum Committee for approval.

V. AP 4105 – Distance Education (I/A)- Perlas

Distance Learning AP. There are small revisions. Addendum to course outline has been added and the Distance Learning committee is speaking about revising the curriculum approval process. Instructor contact and accessibility is detailed. Slight changes in the 'training' section which makes us consistent with statewide standards. A question was raised regarding Proctorio. Currently other online exam programs are being researched. Other option is also to charge students for use of a proctoring program. To ensure instructors meet eligibility, it was recommended that HR add a function in the application to include Faculty online certification documents. CCC Registry is working on keeping a repository of qualified online instructors. It was recommended that we have an ADA 508 discussion to review processes – perhaps agendize at TAC. ACTION: Klever moved. Van Alfen 2nd. All Approved. Forward as-is to College Council.

VI. AP/BP 4226 – Multiple & Overlapping Enrollments (I/A) –DR
