### **Discussion / Action Items**

 Dialogue Facilitation and Action Planning for Fall Flex. What would be most useful for faculty in determining course improvements?

Discussed action plan resources - will focus on questions provided in ASCCC document and examples from Berkeley City College.

How do we create dialog when most faculty are the only instructors for their courses? How do we bring discipline faculty together for dialog? Could provide prompt on form for people to reflect on dialogue.

We want dialogue and documentation of dialogue to connect with program review.

Ann and Liz will pare down the ASCCC document to 4 questions.

Could do a structured exercise - give people 3 min to talk about their reflection and then give each person 1 min to respond (original person can take notes) then go on to next person.

Build break into schedule for fall dialogue session - 10 minutes break after first hour.

Ann will see if we can use Academic Senate funds for refreshments during dialogue.

• Canvas Insights. The Assessment module in eLumen is transitioning to Canvas. We'll provide updates and share what we know so far.

Liz, Ann, JT, Maria, and Matt Donaldson are meeting with Lisa Beach, Director of DE at Santa Rosa JC to discuss the experience their college has had with Insights. An Insights demo will be scheduled over summer.

Goals for next year, 2024-25

Shannamar is willing to continue to serve on the SLO Assessment Committee at the part-time representative. Liz and Ann will arrange for her to receive a stipend for this work.

JT will continue to be on the committee.
