As all of you know, this week, September 11th, commemorates the 23rd anniversary of 9/11. I still remember exactly what I was doing when the attacks transpired as I am sure, all of you do as well. 9/11memorial.org is offering a FREE 9/11 Anniversary Digital Learning Experience. 'The program includes a 30-minute film, available on demand, highlighting first-person accounts of the attacks and their aftermath and a live chat with Museum staff throughout the day. - **Zoom Archive Announcement:** The Chancellor's Office is implementing a new Zoom Recordings Retention Policy, which can be viewed [here](#). In support of this policy, they will be automatically deleting any Zoom recordings stored in the cloud that were made prior to July 31, 2024. This automatic deletion will take place on October 1, 2025. If you have Zoom recordings that you are currently storing in the cloud that you wish to retain, you will need to download them and store them in your personal OneDrive. If you do not know how to do this, please submit a HappyFox ticket so that Tech Services can assist you.
- **Smoke Free Survey:** According to the [Smoke and Tobacco Free Policy Report Card](#), in May 2018, the Board of Governors for the California Community College system adopted a resolution to provide guidance and support for all California Community Colleges to adopt and implement 100% smoke and tobacco-free policies. At that time, 47% (53/114) of community colleges had implemented a 100% smoke or tobacco-free policy. Currently, 69% (79/114) are 100% smoke or tobacco-free. In Spring of 2021, we distributed a Smoke Free Survey. Now that we are out of the COVID 'State of Emergency' we are interested in reassessing.
